I will be responsible for storage fees at the rate of \$25 per day outside, \$35 per day Catamaran, \$50 per day inside storage until the account is settled. I understand the Marina may enforce a mechanic's lien against the boat for all monies due under this work authorization, and I also understand, that I will be responsible for attorney's fees incurred by the Marina enforcing it's rights.
